Maj Gen Rajender Pal Singh, the Vice President gave out the annual audit report to the members. Financial report for the year 2021-21. The report was also put up to each member. The Vice President explained the various income and expenditure heads. The distribution of assets was noted and the expenses were compared to the previous year. 4. Agenda No 3: COVID-19 Assistance.

Mrs. Vijay Laxmi said that this year we are in midst of a humanitarian crisis, whose scale, severity and geographical spread are unseen in a century. She also added that COVID-19 has filled the hearts of all Indians with enormous pain and grief. Several of our villages have borne the brunt of this pandemic. For the toddler family the suffering of any village becomes, suffering for all. Today, all members of the toddlers offer our heart felt condolences. She then requested all members to observe a minute of silence in memory of the departed souls. Toddlers has been very active during COVID times, Hemant and Rupa have been our ambassador to the needy. We have provided cooked foods in Azadpur Mandi and in slums behind Vasant Kunj in Delhi. Outside Delhi we have provided large amount of rations and medical equipment in Tinsukai District of Assam. We are also conducting large number educational programme to brief and educate people on the preventive measure of COVID-19 such as social distancing and wearing of masks.

5. Agenda No 4: Scheme of Library.

Mr. Hemant Swaroop said that, after being registered with Darpan ID we are pursing the scheme of the government to open libraires in village of Bharatpur and Alwar of Rajasthan. In the District of Bharatpur, Capt Lekh Raj has been able to liaise with the six villages Ajana, Ekran, Kasaut, Ghusyari, Taalfara and Bahaj. In the District of Alwar Sub Maj Sharma has been able to liaise with the five villages Gujar Vaas, Jakrana, Jatgaunra, Jaguvass and Pahari.

6. Agenda No 5 : Scheme of Sewing Machine.

Mr. Hemant Swaroop, also brought out that another Scheme of 25 sewing machines per villages for providing employment to ladies, by khadi udyog and other agencies is also being pursued by Toddlers Transformation. In the District of Bharatpur, Capt Lekh Raj has been able to liaise with the six villages Ajana, Ekran, Kasaut, Ghusyari, Taalfara and Bahaj. In the District of Alwar Sub Maj Sharma has been able to liaise with the five villages Gujar Vaas, Jakrana, Jatgaunra, Jaguvass and Pahari.
